Water and Sewer: Trustee Pittard reported that a seal went out at the Hills Creek Lift station. It will need to be replaced.

Streets and Alleys: Trustee Pittard explained that 13 Street East in Fancy Creek is in bad shape. It will need to be addressed.

Finance and Audit: Trustee Einfeldt, Trustee Anderson and Mayor Morrow had a sit-down appointment with Mike Bell at Midwest Bank. The meeting was to discuss possible investment ideas for the money the Village will receive from the sale of the water/sewer systems. More information will be forthcoming. No decision has been made.

Buildings and Grounds: No report

Harbor: Trustee Anderson reported he and Chad Kelly have been trying to get a sit-down meeting with the Corps of Engineers regarding electrical compliance violation that has been received by Kelly's Landing.

Trustee Anderson explained that the work that the Corps wants done at the Harbor is around \$20,000. Chad Kelly believes that the harbor has been Grandfathered in for the electrical compliance.

Parks & Recreations: No Report

Police: Trustee Brackney reported that there is a camper in the alley by the Baptist Church. Several residents have complained about it sitting there as well as the junk around it. It was determined that the camper is on the alley, which belongs to the Village.

The Board has decided to try to contact the owner and/or tag it for removal.

Trustee Brackney also mentioned the home behind Casey's. It needs to be cleaned up.

Justin wants to assure residents that he is in fact attending the meetings. He will be attending 5 or 6 flood meetings as well as an erosion control meeting in the next couple of months.
