#### COMMITTEE REPORTS

**Streets & Alleys:** Trustee Morrow reported that we lost a portion of the road in Fancy Creek. Justin and Mo tore out the panels and replaced them with gravel. The Village had IMEG engineer the road repair in Fancy Creek in 2 phases a couple years ago. Phase 1 has been completed. It's about time to move forward with phase 2. Phase 2 will cost approx. \$200,000.

Trustee Morrow also mentioned that the Village should receive \$140,000 in Covid grant funds. He would like the Trustees to consider using that money for one or two permanent flood pumps along 2<sup>nd</sup> Avenue since the money can be used for infrastructure.

**Harbor:** Trustee Melody reported that he's looking forward to seeing the results of the dredging.

The Village is taking donations toward the camera system to be put at the Community Center (former Lion's Club). Mike Bell mentioned that the MidAmerican Grant we receive every year can be put towards the camera system. Mike also mentioned that Midwest Bank may want to contribute to the cameras. Illinois American Water donated \$1,000. The total cost of the cameras will be around \$5,000.

**Police:** Deputy Beaulieu reported that one car had been stolen over the last couple of weeks. The keys were in the car.

He also mentioned that the 3<sup>rd</sup> shift officers have stepped up the patrols out in the area.

Justin Parchert put the speed radar detector on bank hill again. Speeding is up and the Board is worried that someone is going to get hurt due to the excessive speeds. Slow down.

The zero-turn mower is beginning to nickel and dime us. It might be time to replace it with a new mower. We will also need a new salt spreader.

Justin has been getting the road salt through the City of Davenport. Davenport is discontinuing being the middle man and Justin will have to find a new source by 2022.

The Levee Rehab project should begin soon.

**Old Business:** The Village received the purchase agreements for the Emergency Flood Access Road. Alex McGehee has generously donated a portion of his land. Kodi & Tyler Kargl have agreed to sell the Village the other portion for \$2500.00.
